KERBSIDE RECYCLING AND PLASTICS TYPES 3-7 7

Bryan Hudson – Manager Transportation presented the report and summarised the main points.

Mr Hudson explained that the recommendations in the report to stop collecting materials 3, 4, 6 and 7 in the kerbside collections service resulted from a significant reduction in commodity markets for recycling plastic types 3 - 7, both overseas and the fledgling market in New Zealand for these materials.

It was noted that it was possible there could be a market for these materials again in the future, and in particular plastic type 5, which has the potential to be more widely recycled in New Zealand. The recommendation was to advise Waipa residents to cease placing 3,4,6,7 plastic types in the kerbside recycling bins. Type 5 plastics would still be collected in anticipation of markets being available later in the year.

Mr Hudson advised that a comprehensive communications plan would be developed support the community through this change. The Plan will inform residents what the various plastic types 3 - 7 are and explain clearly the reasons behind the changes, including the cost drivers and market difficulties that had led to the change.

Mr Hudson advised that only a very small volume of plastic types 3 - 7 were currently collected but these still contribute to the costs associated with collection and sorting of all recycling.

- b) As soon as practicable, Council amends the Kerbside Recycling Services Contract 27-18-56 to cease collection of plastic types 3,4,6 and 7 until such time as a market for some or all of these plastics is re-established. Type 5 plastic would continue to be collected in anticipation that a market will be available this year;
- Council commences a significant communications plan with the community to c) support this change in recycling practice when the pandemic alert level allows normal recycling sorting to resume;
- d) Staff continue to monitor the collection of paper and cardboard and recycling opportunities, and report back to the Service Delivery Committee once there is more certainty regarding this.

8 **SECTION 17A REVIEW OF STREET CLEANING SERVICES**

Bryan Hudson - Transportation Manager presented the Section 17A review for Street Cleaning Services.

Under Section 17A Local Government Act 2002, there was a statutory requirement for local authorities to review the cost-effectiveness of current arrangements for meeting community needs for good quality infrastructure, local public services and local regulation. The review must consider the costs and benefits of different options for funding, governance and delivery.

Mr Hudson explained that this option maintained the 'status quo' as the street cleaning service was currently delivered through a measure and value contract. It was more cost

effective to outsource this service as there were suitable contractors that specialised in street cleaning services and have mechanical brooms and vacuum systems designed for the removal of litter and detritus from streets, sumps and kerb and channel. It was advised that contracting out this service continues to be common practice with all our neighbouring local authorities and customarily provided a cost-effective and responsive service.

It was requested that the Community Boards were able to have input into the levels of service to be included in the future tender document as they were able to provide local knowledge on areas in the community that required more attention.
