1 EXECUTIVE SUMMARY – WHAKARĀPOPOTOTANGA MATUA

The purpose of this report is to inform the Te Ara Wai Governance Committee (the Committee) of the support Council has received for the Te Ara Wai project.

This update is in response to discussion at the Committee meeting on 3 April 2023, where members sought to understand the level of support for the project.

Support for the project was extremely encouraging with 29 letters of support (Appendix 1). Key themes of the letters were:

- The articulation of tangata whenua stories in collaboration with mana whenua
- The ability to cater to the powerful surge of interest in the local history of place, providing an authentic experience centred in the place where history happened
- The importance of providing a space to tell the nationally significant stories of Waipā with a particular focus on the New Zealand Land Wars
- Catering to local, regional and national interest, providing increased tourism opportunities
- Contributing to our economic, heritage, cultural and social wellbeings
- Increasing a sense of pride and identity in our community.

An excerpt from the support letter received from Waikato Tainui:

"Much of the rich weave of heritage and geography, and the events and eruptions that happened in the district, have slipped past generations of New Zealanders. Yet it is that very same weave that has shaped our identity. We 'are' because of our past, and by knowing the truth of our past we can better determine our future."

While the location for the development of Te Ara Wai has changed to the Arawata Street site, the fundamental basis and intent of the project remains the same. With little change in the broader sense regarding the key drivers of Te Ara Wai, it is expected the support from these mana whenua partners and other key stakeholders remains the same.

2 RECOMMENDATION – TŪTOHU Ā-KAIMAHI

That the Te Ara Wai Governance Committee receives the report of Anne Blyth titled Overview of Support for Te Ara Wai (document number 11023378).

3 COMMENTARY - KŌRERO

The development of the Te Ara Wai dates back to November 2017. In the time since, several key pieces of work have been completed including the development and launch of Te Ara Wai Journeys, completion of the Concept Master Plan, Commercial and Operational Model, Kaupapa Kōrero lwi Engagement and Architects Brief for a site in Mahoe Street, Te Awamutu.

In late 2018 and early 2019 Council's elected members and staff sought letters of support from mana whenua, key stakeholders and organisations associated with the Te Ara Wai Project. These letters were to provide Council with assurance of support for the project and to strengthen Council's application to the Regional Growth Fund.

Twenty nine letters of support for Te Ara Wai were received by Council. Support came from mana whenua and a wide range of other organisations with interest in the project from sectors covering:

- Education
- Tourism
- Local, regional and national bodies
- Museums
- Historians.

The application to the Regional Growth Fund was unsuccessful and the project then stalled in August 2020 until Council seized the opportunity to acquire the lease of a site in Arawata Street in 2021 for a new location for Te Ara Wai.

Subsequently, funding for the development of Te Ara Wai was approved through the 2021-2031 Long Term Plan.

Re: Te Ara Wai proposal

On behalf of Te Waka, the Walkato region's economic development agency, I write to confirm our support in principle for Waipa District Council's proposed development, Te Ara Wai.

Te Waka was established in July 2018 to lead, support and facilitate regional economic development in the Waikato region. Our mandate is to help create prosperity and growth right across the region. As you are aware, on 14 November 2018 Te Waka launched our 2018-2022 Waikato Economic Development Programme. The priorities outlined in the Programme were developed during the Waikato Economic Summit, where 250 of the region's business, iwi, community and local government leaders were invited for two days in late August 2018.

During the Summit, attendees identified a network of culturally related tourism projects as the number one priority "Te Waka o Waikato – Improved tourism infrastructure, capability/capacity and authentic experiences for visitors". The Programme highlights many of the projects within the tourism infrastructure network, with Te Waka's objective to support development of these projects where the job growth is most needed.

Te Waka's support is therefore contingent upon the development of a business case that demonstrates Te Ara Wai's positive contribution within the authentic tourism and cultural education concept – both locally and regionally.

The authentic regional tourism and cultural education concept is being promoted by Te Waka to government. The network of authentic tourism product, industry and operator development

initiatives is the Waikato region's single biggest short-term job growth opportunity. The linking of these initiatives will greatly magnify the benefits for the region and result in jobs where they are needed most. The package leverages the Maori economic powerhouse to underpin a substantial cultural education component for which there is significant demand.

Te Waka is working with Waikato Tainui, Tainui Waka Tourism, Hamilton Waikato Tourism, Tainui Group Holdings, Momentum Foundation, Hamilton Airport and Waipa, Hamilton and Waikato Councils to finalise the prioritised list of projects that will form the network. Following a briefing to Minister Robertson on 18 January 2019 and Minister Jones on 27 February 2019, they are expecting a paper from Te Waka framing the authentic tourism and cultural education concept and list of projects that form the network. This will allow PDU officials to better assess individual PGF applications by also taking into account the network effect of the total concept.

The Te Ara Wai initiative is an integral component of the network. The network spans from Rangariri in the North following the Waikato River. Te Ara Wai forms an important hub for the network concept, telling the story about the Maori land wars and cultural history, and linking with tourism products in the highly deprived districts in Southern Waikato. It incorporates training in digital technologies with partnerships planned with Wintec and Te Wananga o Aotearoa to establish training opportunities for young people and a potential foundation for delivering cultural education.

In summary, I believe the Te Ara Wai proposal offers significant potential benefits for Waikato. Te Waka's support is contingent upon there being a net positive economic impact to the region and that it positively contributes to the network of tourism product in the region. We understand that Waipa District Council plans to commission a business case to demonstrate these benefits as the next stage.

I am happy to lend the full support of Te Waka to this proposed next step.

The Te Ara Wai and Journeys Project not only assists with delivering the goals of our Tourism Opportunities Plan, it also aligns to one of our five game-changer projects 'The Home of Kingiitanga' - delivering a suite of Māori visitor experiences that tell the distinctive story of our region's historic importance in a range of ways and places.

Telling the story of the New Zealand Wars, and specifically the Waikato Wars, aligns with our aspirations to grow and develop authentic visitor experiences anchored in our sense of place, people and culture. In the wider regional sense, it also provides an additional destination on the journey of the New Zealand Wars from our main gateway at Rangiriri.

I write in full support of the visionary proposal of Waipa District Council to develop the Te Ara Wai Museum Discovery Centre. I also note that this project has the full support of the Waikato Mayoral Forum, Te Waka, the Waikato region's economic development agency, and that it is being undertaken in partnership with Iwi.

The Waikato region contributes significantly to New Zealand's rich cultural heritage and the Waipa district is very much central and integral to that. Much of the Waikato Land War occurred within the Waipa district from just south of Ngaruawahia to its culmination at the Battle of Orakau. Also, and very importantly, some major inter-tribal battles (Hingakaka, Matakitaki, Taumatawiwi) and events that had significant impacts on those tribes occurred within Waipa district.

During this period there were eras and events of significance that played important roles in shaping our region and country including Missionary influence, Maori agriculture, Main Trunk railway development of vast peat swamps and the growth of the dairy industry.

These stories must be told to our more enquiring generation and this purpose built centre using modern interpretive learning mediums will do just that.

Unlike other countries, there has been a real shortcoming in us telling the story of battles that were to shape our country. This was poignantly brought home to me when attending the 150th anniversary of the Battle of Orakau with there being nothing to tell this defining story. Te Ara Wai will do that for present and future generations.

The project is to be congratulated in having lwi partnering in the planning and implementation. From a Waikato regional perspective, Te Ara Wai will provide a regional and national focus and be a significant contributor to our economic, heritage, cultural and social wellbeings. As proposed, it will showcase, tell the stories, educate and provide research.

I write on behalf of the Mayor and Councillors of the Otorohanga District to express support for the proposal of Waipa District Council to develop the Te Ara Wai Museum Discovery Centre.

Much of the rich history of our region is shared by the Waipa and Otorohanga Districts, and we believe that this history is currently often not adequately recognised.

The Waikato Land Wars in particular are something that had broad effects in our area, but which are only now beginning to again be properly appreciated, as for example reflected by students of Otorohanga College recently being the initiators of a national petition to parliament that sought greater formal recognition of these events.

Whilst Otorohanga has a small but well run local museum it is volunteer operated and does not have the resources to provide the type of broad and impactful visitor experience that Te Ara Wai could give, and as such we believe that this proposed new project would be very complementary to our local facility.

It is believed that a facility such as Te Ara Wai would be of benefit both through enabling local people to better understand the history of their region, and as a potential destination for tourists, very large numbers of whom – believed to be in the order of 1 million per year - currently pass quickly through our districts on route to the Waitomo Caves and other attractions to our south



Te Ara Wai

The Waipā district is rich in heritage and history. In the mid-nineteenth century it was one of the most important centres of economic activity in the country, not just feeding the residents of Auckland but also exporting produce as far away as Victoria and even California. That activity was led by its overwhelmingly Māori population.

The invasion of Waikato followed in 1863, of course, as did sweeping land confiscations that destroyed almost overnight the previously thriving Māori economy of the region. Many of the most important conflicts of the New Zealand Wars, including the battle of Ōrākau and the attack on the civilian settlement of Rangiaowhia, took place in the Waipā district.

These were defining events in New Zealand history and certainly in the history of the Waipā region, but have not always been remembered in this way. And that is why Te Ara Wai, the proposed new Waipā heritage centre, is an idea whose time has come.

Te Ara Wai will allow these and many other local stories of importance to be told in dynamic, varied and engaging ways. I endorse Waipā District Council's decision to invest in this important new centre, one that is sure to attract many local, national and international visitors to its doors.

I am writing to support the development of Te Ara Wai – the proposed museum/discovery centre at Waipā. I can speak from two particular perspectives – as the publisher of Vincent O'Malley's *The Great War for New Zealand: Waikato 1800-2000* (and forthcoming book for schools and general readers on the New Zealand Wars), and as a long-time publisher of New Zealand history, working closely with not only leading historians but also with the country's wonderful network of museums.

As others will be documenting, the Waipā District is without a doubt one of the New Zealand places most densely layered with narratives about our past. The history of Waikato-Tainui is present in this landscape, as is the settler narrative, the story of the New Zealand wars, and the country's farming development (to name only key strands). These local narratives are present in all key New Zealand histories – and in Bridget William Books' list, not only Vincent O'Malley's recent work, but also in the award-winning *Tangata Whenua: An Illustrated History* by Atholl Anderson, Judith Binney and Aroha Harris.

The value of a museum and learning space within this landscape, as proposed with Te Ara Wai, cannot be underestimated. As book publishers, we work increasingly with museums around the country – holding talks and supporting school visits. In 2018, for example, we worked with the Auckland Museum to facilitate Vincent O'Malley's talks about the wars to Auckland schools, and organised talks with different authors (all historians) at Puke Ariki in New Plymouth, the National Library, the Otago Museum and Te Papa. We have an ongoing programme for organising Historian Talks in Schools, in part inspired by the Waipā Council's initiative in bringing Vincent O'Malley to the Waikato for a series of school talks in 2017. We also work closely with museums to ensure that our illustrated histories are informed with images reflecting local histories accurately. We rely on and greatly value these museum connections.

There is a powerful surge of interest in the local history of place, in the schools and amongst both New Zealand and international tourists. And this engagement needs to be centred in those places where history happened (not in the main centres).

Bridget Williams Books is committed to the development and dissemination of accessible, evidence-based knowledge about New Zealand and its past. Our publishing philosophy is based on a belief that knowing the past informs our understanding of the present, and thus enables a fuller participation in our society. Knowing the past, we believe, enriches both the present and the future.

We see local museums in places rich in history as making an invaluable contribution, and wholeheartedly support the project Te Ara Wai.
