The consultation discussion has been misrepresented. The minutes of the consultation meeting are not included with the AEE as stated.	The society seek that the current plan be retained in its entirety and the Council recommend the designation be withdrawn.
4/2	Transportation	Proposed Private Plan Change 10 Hamilton Airport and Notice of Requirement State Highway 21	Oppose	The proposal presents significant transport effects along SH21. The daily traffic counts do not include the events held at Mystery Creek. The use of the existing slip lane will not be possible with the proposed roundabout layout. A one lane roundabout will not be able to accommodate event day traffic. Concerns that the separation distance between the proposed roundabout and Mystery Creek Road is insufficient for slow long turning vehicles. The applicant has not adequately addressed the potential increased traffic volumes arising from wider development within the area. Consequential adverse economic effects. Support for the roundabout concept which will resolve several issues associated with combined entrances, close proximity of airport and Fieldays access points and use of existing slip lane. Support for the new access from SH21 to the Southern Precinct.	The design of the roundabout should provide access to the club to allow heavy machinery entry.
