General conditions

- 1. The Council Officer is permitted to seize or detain all fittings, standpipes hoses, etc who are not permitted users or as a result of any breach of these conditions.
- 2. No water is to be drawn off by use of a fire hydrant.
- 3. All charges must be paid by the due date.
- 4. The applicant will be liable for any damages to Council property or a third party.
- 5. Bulk water filling stations are to be locked on departure.
- 6. No permits will be issued for more than 12 months.
- 7. This permit must be renewed before 30th June, each year to be considered valid.
- 8. The applicant is required to inform the Council Officer of any possible defect or damage to the Filling Station.
- 9. The applicant will be held responsible for the cost of any repairs of damage caused by the incorrect operation of a tanker filling station.
- 10. The applicant will also be held responsible for any third party damage that occurs whilst the tanker filling station is in use.
- 11. The applicant must comply with all conditions stated on the permit upon approval.
- 12. If any water drawn is to be provided for drinking water to customers, the water carrier must be registered with the Ministry of Health of Drinking water supplies or suppliers.

- 14. Council reserve the right to review, change or revoke these conditions, at any time.
