# Notification of Decision on Private Plan Change 20: Airport Northern Precinct Extension to the Waipā District Plan

Public notification pursuant to clause 10(4) of the First Schedule of the Resource Management Act 1991.

In accordance with clauses 10(4) and cl29(5) of the First Schedule of the Resource Management Act 1991, Waipā District Council gives notice that Council's decision to Private Plan Change 20: Airport Northern Precinct Extension is now available.

In summary, the amendments to the District Plan include the following sections:

- Amendments to the following sections of the District Plan:
  - Section 10 Airport Business Zone
  - Section 15 Infrastructure, Hazards, Development and Subdivision
  - o Section 21 Assessment Criteria and Information Requirements
  - o Appendix S10 Airport Business Zone Structure Plan
  - Volume 3 Planning Maps
- The amendments include the following provisions:
  - o Enabling development of the Northern Precinct in line with the Proposed Structure Plan.
  - o Removal of the requirement for a Comprehensive Development Plan.
  - Requiring specific transport upgrades triggered at specific stages of development.
  - Enabling and consolidating non-ancillary retail activities within specific areas.
  - Requiring the establishment of landscaping on specified boundaries.
  - o The establishment of an Ecological Management Plan for the entire Northern Precinct.
  - o Rules managing vegetation trimming, pruning and removal within the Northern Precinct.
  - Application of a noise limit within the notational boundary of 141 Middle Road.
  - Requirement for buildings within the Northern Precinct to be designed in accordance with the NZ Fire Service Fire-Fighting Water Supply Code of Practice.
- Consequential renumbering of provisions / references / page numbers in the Plan may be required due to the proposed changes above.
