In relation to Item 4 - effect on the surrounding environment, and in particular bullet point 1, "transport effects on the wider network". At the Raynes Road / Airport Road intersection, and at the Raynes Road / SH3 intersection, there is significant congestion and this has increased with the opening of the Waikato Expressway. Neither intersection is modernised for high use, and for truck use. These intersections are already failing, with recent fatalities. This plan will exacerbate these dangerous intersections, an offence against safety + health. Intersection upgrades required!
