With respect to Lot 6 DPS 64524 it is my contention that, The Waipa District Council, Urban Flood Hazard Maps whilst providing a reasonably accurate indication of the 1% AEP Modelled Flooding Extent: Existing, does not indicate reasonably the 1% AEP Modelled Flooding Extent: Climate Change RCP6.0.

The 1% AEP Modelled Flooding Extent: Climate Change mapping has not taken into account recent land development to the south of the subject property nor the true contours of the adjacent southern properties or the overland flow path on the subject site.
